In response to question two, the Seismic Structural Status report for HBDHB will also be made publicly available soon, and therefore HBDHB declines your request under s18 (d) of the Act.

In response to question three, consultants provided information that helped form the June 2021 Seismic Structural Status report but they did not write the report.

In response to question four there was no independent review by another DHB of the Radiology project preliminary design.

In response to question five the reports provided by WSP consultants are the first documents HBDHB received indicating that the Radiology project had original seismic costs that were underscoped and that additional seismic bracing was required in Radiology and ED.
