YOUR OFFICIAL INFORMATION ACT (1982) REQUEST HBDHB REF: OIA2022008

I refer to your Official Information Act request dated 27 January 2022 where you requested information from Hawke's Bay District Health Board (HBDHB). Your questions and HBDHB's response is provided below:

• Data showing the total population covered by the DHB's mental health and addiction services at the end of December 2021.

Hawke's Bay DHB's Mental Health and Addiction Service (MHAS) covers the region's population of 178,500.

 Data showing the total number of full-time staff employed by the DHB's mental health services in each of the last three years to the end of December 2021, particularly the number of psychiatrists, psychologists, and nurses.

Total full time staff in Mental Health & Addiction Services was 133 in 2019, 141 in 2020 and 144 in 2021.

In 2021, vacancies were across the organisation and included teams such as community support workers, mental health crisis team, acute mental health inpatient team, Te Harakeke, Naā Rau Rākau, mental health intensive services, community mental health, psychiatry, clinical psychologists, addiction services team and non clinincal teams such as security and police liaison.

Please note that these figures are openings rather than FTE required. This means that some openings might be at 0.2 FTE, some may be for 0.5 FTE etc.

Hawke's Bay DHB declines to release this review document under s9(2)(a), s9(2)(ba) and s9(2)(g)(i) of the Official Information Act, relating to protecting the privacy of natural persons, prejudice the future sharing of information that was given to the authors in confidence and maintaining the free and frank expression of opinions of employees.

 Copies of key documents held by senior management created in the last two years that were substantially about the impact of the Covid-19 pandemic on your mental health and addiction services. The DHB does not hold any documents by senior management created in the last two years that were substantially about the impact of COVID-19 on MH&AS and therefore declines this portion of your request under s18(e) of the Official Information Act relating to data that does not exist.
